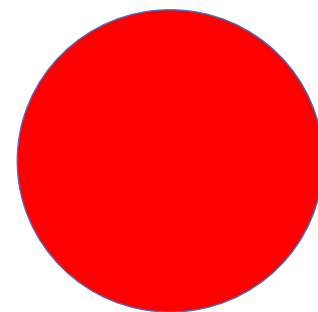

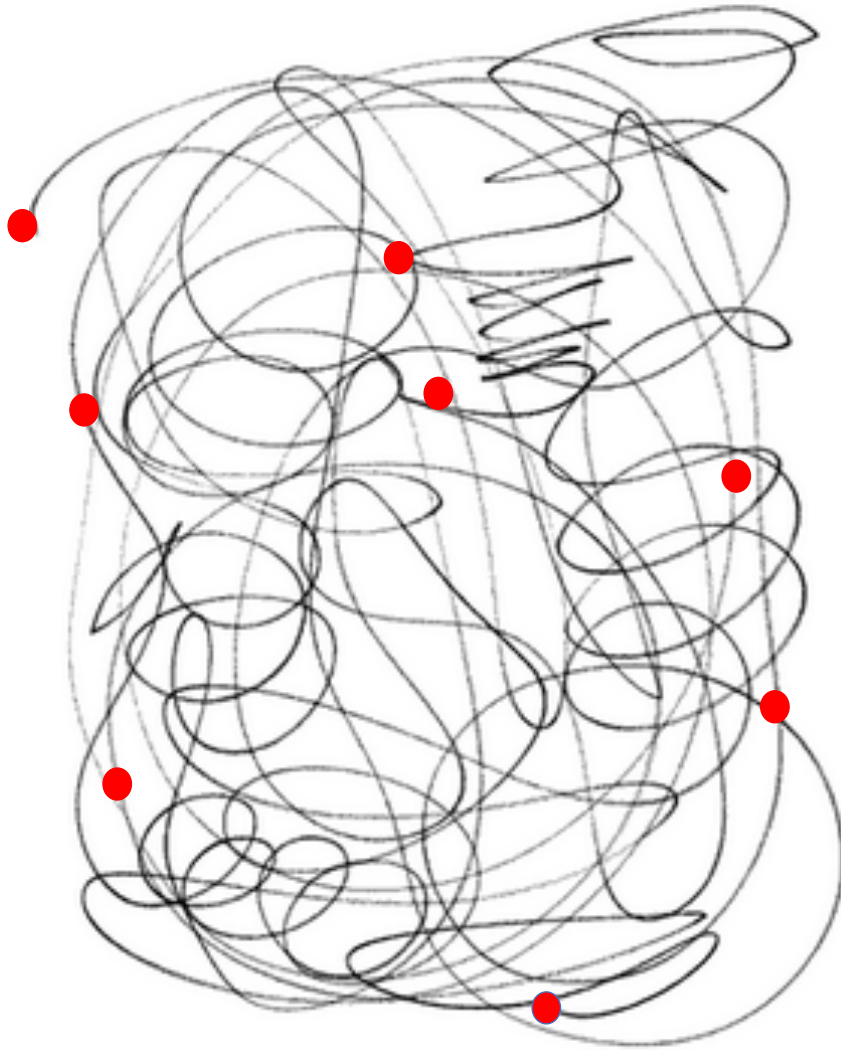

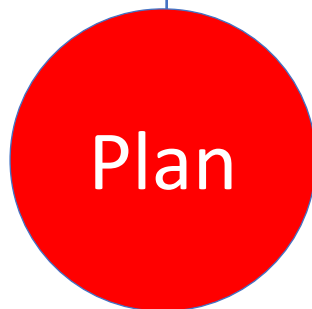

A straight line





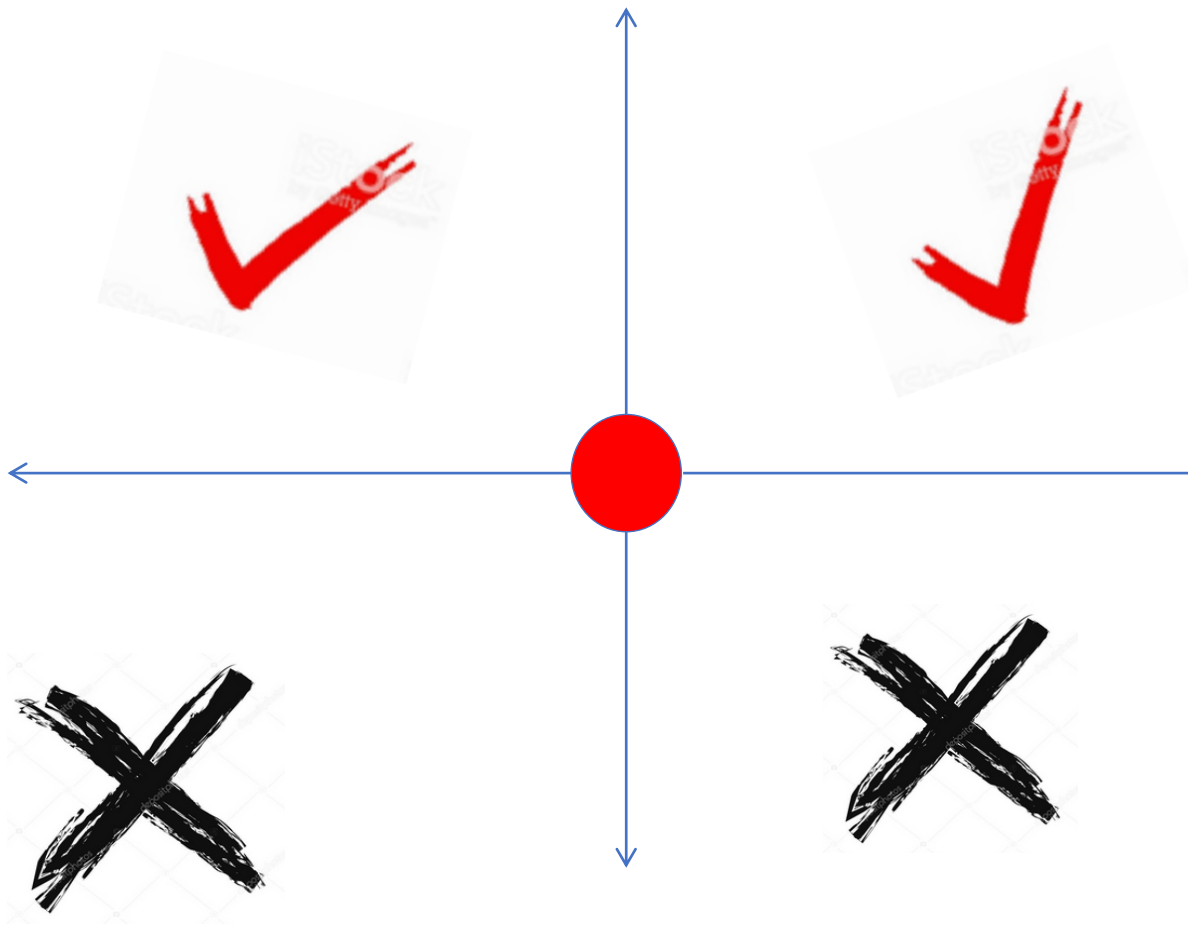

17th December 2002. Council meeting. The council decides to relocate the street market that sells on avenue 12 of October.

22nd January 2003. ROBLES asks ANDRADE for an Urbanization license. Apparently WM is going to pave a dead-end street next to the store. He is granted this license almost 3 weeks later.

22nd January 2003. We know from documents in the Municipality that ANDRADE is calling the DIRECTOR responsible de Obra to go certify that ARRENDADORA dumped excavation material in the creek and in a private property in the outskirts of the town – the owner has complained and the municipal inspectors have already verified this. ANDRADE instructed ROBLES the site where they should take the debris, back in November. This is the first time we see ANDRADE copying other officials in his rulings. This case goes on for weeks. On the 14th March 2003, the owner of the plot forgives Arrendadora in a letter to the municipality. He writes that the problem has been solved and that he has been compensated for the damages caused.

27th January 2003. Council meeting. The council decides to cancel the contract with the person who was hired to put together a new Plan. No idea why. They also decide to halt the construction of the Jesus Cerna Juárez avenue and terminate construction contracts, due to the territorial dispute with Uriangato. They are desperate for a ruling from the state Congress over the boundaries.

The street vendor's association that was removed from 12 of October street gives the council 3 other alternative spots to set their market up. The council decides to relocate them in one of these. The leader of this Asociación Civil Tianguis Esquipulitas is Miguel ANGEL ZAVALA MARTINEZ. No record anywhere that there was any opposition.

28th January 2003. I believe this is when they get the Environmental Impact ruling, as far as I learned from a very bad copy. The document says they received a request for this ruling back in July 23rd 2002, they received the study in December 2002. No indication here that they were aware it was under construction already. We have FOIAD.

6th February 2003. ANDRADE authorizes ROBLES to break the pavement in order to connect the facility to the water? Network.

13th February 2003. ANDRADE gives ROBLES the Urbanization license to pave the short street and sets a series of technical requirements for the cement...

3rd March 2003. ROBLES asks for the operation license for the store. They need it in order to get the State Alcohol license. Since June 2002, the Council has to give its ok so that the state government issues this license.

11th March 2003. Municipal council session. The records of all these sessions are not transcripts but rather summaries. We cannot really tell what the discussion was like in

any of the municipal council minutes available. The 6th issue that date was a WM request brought forth by ANDRADE; he presents a letter by JOSE LUIS HERNANDEZ, another of WM's legal reps, that says the store will be operating starting November, and they are requesting a change in uso de suelo so that they may operate a self service store WITH alcohol sale. This, so they can then get the state alcohol license. The council approves. There is 1 Regidor who doesn't. "SAÚL LÓPEZ LÓPEZ expressed that this authorization is a special treat for the Bodega Aurrera, since the municipality has followed the norm of not handing out permits for the sale of alcohol".

This is happening 2 months before opening day.

10th March 2003. Date on two of ALEGRIA's invoices, according to the Listado de Pagos file. We cannot be certain they have to do with this store, but the match in dates is relevant. ALEGRIA is handing in 2 invoices for the "1st stage gestoria for an uso de suelo change". One is for 48,750 pesos, the other for 325,000 pesos. Both checks are issued on the very next day. There is a 3rd invoice dated 12 March, paid 13th March for "complementary uso d" for 55,000 pesos.

There is another payment made for the 1st stage gestoria uso de suelo change on the 18th March for 345,000. And we will see other invoices handed in on the first days of June for the remaining payment due for the uso de suelo license.

26th March 2003. Council session. Around the end of the meeting, ANDRADE brings up NUEVA WAL-MART's request to set up 12 ads in the area, to direct people to their store. "This company informs that they are willing to make extra publicity that the Municipality may require". The council authorizes them to put up ads, unless the Municipality decides they conflict with municipals interests –if they affect the urban image...- in which case they may order its removal. "In regards to their willingness to support the Municipality with some publicity, we could request them to elaborate 200 street name signs.

They also decide to ask WM to install a billboard that says "Welcome to Moreoleón" on the entrance to town, including their publicity". ((according to a municipal officer I talked to, they ended up removing this sign because it fueled the fight with Uriangato)

Around town, the street signs are a work made in iron. These were pretty bad versions... stickers on metal. Very ugly.

1st Apr 2003. Date on a document written by ANDRADE to ARRENDADORA. He's responding to the company's 3rd of March request to get the Operation permit for the store, and the municipal's consent for the sale of alcoholic beverages, a necessary authorization to get the State Alcohol License.

ANDRADE informs ARRENDADORA that the Municipal Council voted in favor of their request in a March 11 session. He then grants them the "uso de suelo and operation license for a self-service store, grocery, shack (tendajón) and the sale of alcoholic

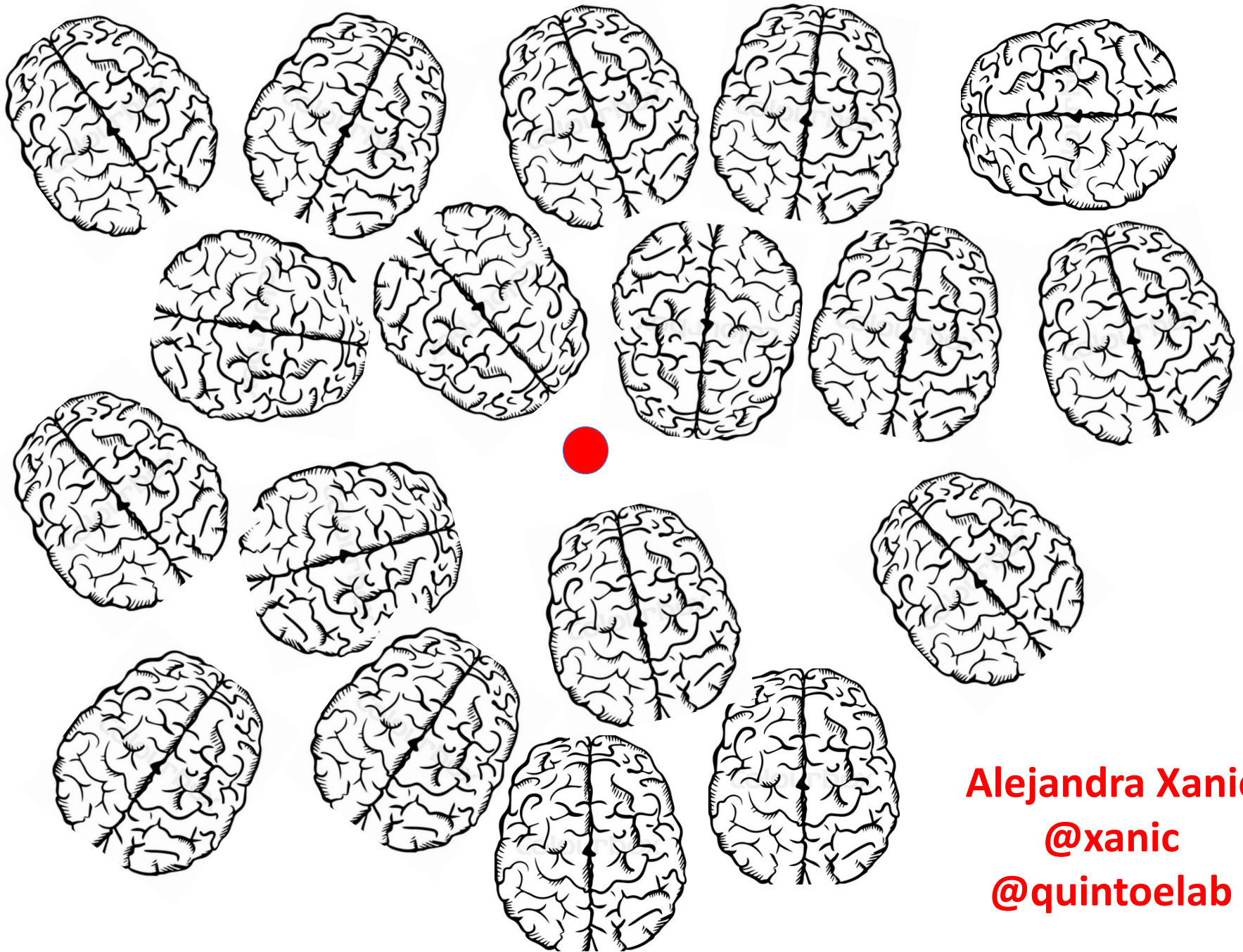
